TDM PAYS PROFIT SHARING TO LEMBAGA TABUNG AMANAH WARISAN NEGERI TERENGGANU (LTAWNT)

Kuala Terengganu – TDM Berhad ("**TDM**" or "**Company**") had made payment of share of profits on Joint Venture for financial year ended 31 December 2019 to Lembaga Tabung Amanah Warisan Negeri Terengganu (LTAWNT) today at Wisma Darul Iman.

The cheque of profit sharing was handed over to LTAWNT Secretary, Mr. Abd Razak Abd Rahman by TDM Berhad Director, Haji Burhanuddin Hilmi Mohamed @ Harun and witnessed by Terengganu State Secretary, YB Dato' Mohd Zahari Md Azahar.

The company has paid a profit of RM1,048,928.00 to LTAWNT from the companies' joint venture partnership.

The Group Plantation business's revenue was flat at RM188.4 million but registered higher crude palm oil ("CPO") and palm kernel ("PK") production in FY2019 compared to FY2018 by 15% and 13% respectively. However, this was partly offset with lower average selling price of CPO by 8%, and PK by 32%.

TDM's Chairman Yang Mulia Raja Dato' Haji Idris Raja Kamarudin said, "the profit payment is a testament to our commitment to provide sustainable contribution to the land owner from the land that has been entrusted for us to manage."

LTAWNT owns 1,336 hectares of oil palm plantation which is developed by TDM Berhad through a joint venture that was established since 1996.

Also present at the event were TDM Board of Directors, Chief Financial Officer and Management team.

TDM Berhad runs its businesses following the Shariah Compliance guidelines to maintain the high standards of operations and products and will continue to deliver great value, quality, and excellence to all of its stakeholders. The company expects to be back in Shariah Compliance status based on SC's Shariah screening methodology in the next review this November 2020.
